- Marketing M.Sc. Bonn-Rhein-Sieg University of Applied Sciences
 - Average grade at least 2.3
 - The proportion of business modules must be at least 70 credit points (ECTS). If the requirements are met, the study places are allocated via a local selection procedure (NC procedure).
 - Students from the Bonn-Rhein-Sieg University of Applied Sciences must apply via SIS.

Marketing Master

- Management und Marketing M.Sc. University of Wuppertal
 - A bachelor's degree in an economics course that was completed at least among the top 65% of graduates. If it is not possible to provide evidence of a relative grade, at least the overall grade (decimal grade) "2.5" must be proven. However, the relative grade and not the decimal grade always counts first.
 - Of these, at least 15 CP in the field of business administration and at least a further 15 CP in the field of economics.
 - In addition to a thesis, at least 6 CP must have been acquired through one or more term papers or seminar papers that meet academic standards.
 - German language skills at least at level "A2"
 - Language of instruction is English and German

Economics Master



- Economics (M.Sc.) University of Bonn

- Free admission
- GRE/GMAT: Not required
- Letters of recommendation: One, from your professor (see here)
- Motivational letter: Not required
- Degree required: B.Sc. or B.A. in Economics (3 or 4-year degree)
- GPA required: German 2.3 or better
- Background required: solid quantitative skills i.e. in mathematics (differential and integral calculus, linear algebra), statistical methods (descriptive and inferential statistics), and **econometrics**
- GRE test scores (not mandatory). Good quantitative reasoning scores in the GRE test can improve the chances of being admitted, especially for candidates who received their degree from universities outside the EU.
- English proficiency: B2 level (CEFR)
- German proficiency: Not required

Economics Master

- Master Econometrics (M. Sc.) University of Duisburg-Essen
 - Corporation of TU Dortmund University Ruhr University Bochum and University of Duisburg-Essen.
 - A B.Sc. or equivalent degree in Economics, Mathematics, Statistics or a related discipline is required. At least 15 ECTS in both Economics and mathematics/statistics/econometrics are required.
 - Econometrics is an English-language Master's program. Candidates must provide evidence of sufficient knowledge of English (at least level B2). We accept certificates for the following English-language tests: TOEFL internet-based test 100, International English Language Testing System (IELTS) Band 6.5 or similar certificates.
 - Applicants must submit an essay of at most two pages on their academic background in view of the pursued master program on Econometrics.

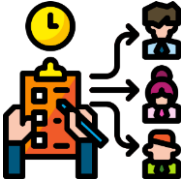
Taxation, Controlling, Finance, Accounting Master

- Economics and Finance M.Sc. Rhine-Waal University of Applied Sciences
 - Proof of a first professional university degree in a relevant subject with at least 210 ECTS points or seven regular full-time semesters.
 - Overall grade of the first degree of at least 2.5 or according to the ECTS grading scale of A or B
 - Language of instruction is English

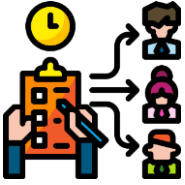
Taxation, Controlling, Finance, Accounting Master

- Accounting, Auditing & Taxation M.Sc. University of Siegen
 - Language of instruction German and English
 - The bachelor's examination in the business administration course or a comparable examination with an economics component of at least 90 credit points. The grade of the degree must be at least good (2.5). In addition, 8 credit points from the field of law in the German language and knowledge of the English language at level B2 are required.

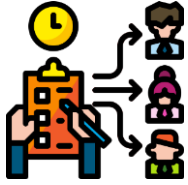
Management Master

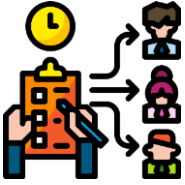

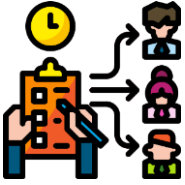
Management Master

- International Management and Psychology M.Sc. Rhine-Waal University of Applied Sciences
 - a professional university degree (B.Sc., B.A., diploma) in a relevant subject (psychology, business psychology, business administration or economics with a social or behavioural profile)
 - an overall grade of at least 2.0 for the first degree
 - Ideally, a total study period of 7 full-time semesters or at least 210 ECTS points (for Bachelor graduates with fewer than 210 ECTS points, the entry requirement can be ensured by catching up on defined modules)
 - 15 ECTS in the field of empirical research methods and statistics
 - Proof of sufficient English language skills at level B2 according to the Common European Framework (CEF)
 - Language of instruction is English

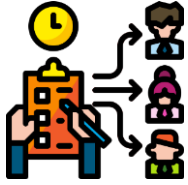
Management Master

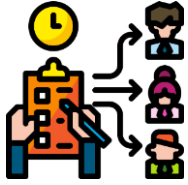
