On the basis of § 2 paragraph 4 and § 64 of the Act on the Universities of the State of North Rhine-Westphalia (Higher Education Act - HG NRW) in the version published on 16 September 2014 (GV. NRW. page 547), last amended by the Act of 30 June 2022 (GV. NRW. p. 780b), the Faculty of Applied Natural Sciences of Bonn-Rhein-Sieg University of Applied Sciences has issued the following regulations:

Preamble

The curriculum of the existing Bachelor's degree programme Applied Biology on the basis of the Bachelor's examination regulations of 16.7.2008 (official announcement No. 19/2008 last amended in the version of the 4th amendment regulations of 28.3.2019 (official announcement No. 5/2019: hereinafter "BPO Applied Biology B.Sc. 2008 in the version of the 4th amendment regulations of 28. 03.2019") will be modified from the winter semester 2023/24 on the basis of the Examination Regulations General Part (PO-A) (official announcement no. 07/2023) as well as the Bachelor Examination Regulations (study programme specific part) Applied Biology in the version of 23.03.2023 (official announcement no. 08/2023) (hereinafter: "BPO Applied Biology B.Sc. 2023"). Examinations according to the examination regulations BPO Applied Biology B.Sc. 2008 in the version of the 4th amendment dated 28.03.2019 will be offered for the last time at the end of the summer semester 2027.

§ 1 Cancellation or Amendment of the Examination Regulations

(1) In the winter semester 2022/23 students were admitted to the first semester of the Applied Biology B.SC. degree programme for the last time under the examination regulations BPO Applied Biology B.Sc. 2008 in the version of the 4th amendment regulations dated 28.3.2019.

- (2) The examination regulations BPO Applied Biology B.Sc. 2008 in the version of the 4th amendment regulations of 28.03.2019 for the degree programme B.Sc. Applied Biology shall be revoked as of 31.08.2027.
- (3) From the winter semester 2023/24 onwards, the degree programme Applied Biology B.Sc. shall be offered based on the Examination Regulations General Part (PO-A) of 23.03.2023 and the BPO Applied Biology B.Sc. 2023 of 23.03.2023.
- (4) Insofar as regulations in the BPO Applied Biology B.Sc. 2008 in the version of the 4th Amendment Regulations of 28.03.2019 contradict the regulations of the Examination Regulations General Part (PO-A) (official announcement No. 07/2023) or regulate something else, the regulations of the PO-A are decisive and take precedence.
- (5) Enrolment in higher semesters in the B.Sc. Applied Biology degree programme on the basis of the examination regulations BPO Applied Biology B.Sc. 2008 in the version of the 4th amendment regulations of 28.03.2019 is only possible in the winter semester 2023/24 and in the summer semester 2024. § 1 (4) shall apply accordingly.
- (6) From the winter semester 2024/25 onwards, enrolment in higher subject semesters is only possible in the Applied Biology B.Sc. degree programme based on the Examination Regulations General Part (PO-A) and the BPO Applied Biology B.Sc. 2023.

§ 2 Discontinuation of the courses

The dates until which the respective courses of the study programme B.Sc. Applied Biology based on the examination regulations BPO Applied Biology B.Sc. 2008 in the version of the 4th amendment regulations of 28.3.2019 are offered for the last time are listed in the appendix.

§ 3 Discontinuation of the examination programme

- (1) Enrolled students shall be allowed to continue their studies until the end of the standard period of study plus four semesters.
- (2) The dates until which the examinations of the B.Sc. Applied Biology programme are offered for the last time based on the examination regulations BPO Applied Biology B.Sc. 2008 in the version of the 4th amendment regulations of 28.3.2019 are listed in the appendix.

§ 4 Final Provisions

Students of the Bachelor's degree programme B.Sc. Applied Biology on the basis of the examination regulations BPO Applied Biology B.Sc. 2008 in the version of the 4th amendment regulations dated 28.3.2019 who have not completed their studies by the specified date (§ 1 Para. 2) shall be exmatriculated in accordance with § 51 Para. 1 No. 3 HG, unless they transfer to the examination regulations BPO Applied Biology B. Sc. 2023 or to another degree programme of the university upon application.

§ 5 Entry into force

These regulations shall be published in the official announcements of the Bonn-Rhein-Sieg University of Applied Sciences (Announcement Gazette). They shall come into force with effect from the winter semester 2023/24.
