defining the phasing out of the teaching and examination programme for the Master's degree course Biomedical Sciences M.Sc. at the Rheinbach Campus of Bonn-Rhine-Sieg University of Applied Sciences on the basis of the examination regulations of 01.09.2008 in the version of the 4th amendment regulations of 19.11.2020

On the basis of § 2 paragraph 4 and § 64 of the Act on Higher Education Institutions of the State of North Rhine-Westphalia (Higher Education Act - HG NRW) in the version published on 16 September 2014 (GV. NRW. page 547), last amended by the Act of 30 June 2022 (GV. NRW. p. 780b),

the Faculty of Applied Natural Sciences of Bonn-Rhein-Sieg University of Applied Sciences has issued the following regulations:

Preamble

The curriculum of the existing Master's degree programme Biomedical Sciences on the basis of the Master's Examination Regulations of 01.09.2008 (official announcement no. 01/2009) last amended in the version of the 4th Amendment Regulations of 19.11.2020 (official announcement no. 12/2020: hereinafter "MPO Biomedical Sciences M.Sc. 2009 in the version of the 4th Amendment Regulations of 19. 11.2020") will be modified from the winter semester 2023/24 on the basis of the Examination Regulations General Part (PO-A) (official announcement no. 07/2023) as well as the Master's Examination Regulations (programme-specific part) Biomedical Sciences in the version of 23.03.2023 (official announcement no. 11/2023) (hereinafter: "MPO Biomedical Sciences M.Sc. 2023"). Examinations according to the examination regulations MPO Biomedical Sciences M.Sc. 2009 in the version of the 4th amendment regulation dated 19.11.2020 are offered for the last time at the end of the summer semester 2026.

§ 1 Cancellation or Amendment of the Examination Regulations

- (1) In the winter semester 2022/23 students were admitted to the first semester of the Biomedical Sciences M.Sc. degree programme for the last time under the examination regulations MPO Biomedical Sciences M.Sc. 2009 in the version of the 4th amendment regulations dated 19.11.2020.
- (2) The examination regulations MPO Biomedical Sciences M.Sc. 2009 in the version of the 4th amendment regulations of 19.11.2020 for the degree programme M.Sc. Biomedical Sciences shall be revoked on 31.08.2026.

- (3) From the winter semester 2023/24 onwards, the study programme Biomedical Sciences M.Sc. shall be offered based on the Examination Regulations General Part (PO-A) of 23.03.2023 and the MPO Biomedical Sciences M.Sc. 2023 of 23.03.2023.
- (4) Insofar as regulations in the MPO Biomedical Sciences M.Sc. 2009 in the version of the 4th Amendment Order of 19.11.2020 contradict the regulations of the Examination Regulations General Part (PO-A) (official announcement No. 07/2023) or regulate something else, the regulations of the PO-A are decisive and take precedence.
- (5) Enrolment in higher semesters in the M.Sc. Biomedical Sciences degree programme based on the MPO Biomedical Sciences M.Sc. 2009 examination regulations in the version of the 4th amendment regulations dated 19.11.2020 is only possible in the winter semester 2023/24 and in the summer semester 2024. § 1 (4) applies accordingly.
- (6) From the winter semester 2024/25 onwards, enrolment in higher subject semesters is only possible in the degree programme Biomedical Sciences M.Sc. based on the Examination Regulations General Part (PO-A) and the MPO Biomedical Sciences M.Sc. 2023.

§ 2 Discontinuation of the courses

The dates until which the respective courses of the study programme M.Sc. Biomedical Sciences based on the examination regulations MPO Biomedical Sciences M.Sc. 2009 in the version of the 4th amendment regulations dated 19.11.2020 are offered for the last time are listed in the **appendix**.

§ 3 Discontinuation of the examination programme

- (1) Enrolled students are allowed to continue their studies until the end of the standard period of study plus four semesters.
- (2) The dates until which the examinations of the M.Sc. Biomedical Sciences programme are offered for the last time based on the examination regulations MPO Biomedical Sciences M.Sc. 2009 in the version of the 4th amendment regulations dated 19.11.2020 are listed in the appendix.

§ 4 Final Provisions

Students of the Master's programme M.Sc. Biomedical Sciences on the basis of the examination regulations MPO Biomedical Sciences M.Sc. 2009 in the version of the 4th amendment regulations dated 19.11.2020 who have not completed their studies by the specified date (§ 1 Para. 2) shall be exmatriculated pursuant to § 51 Para. 1 No. 3 HG unless they transfer to the examination regulations MPO Biomedical Sciences M. Sc. 2023 or to another programme of the university upon application.

§ 5 Entry into force

These regulations shall be published in the official announcements of the Bonn-Rhine-Sieg University of Applied Sciences (Announcement Gazette). They shall come into force with effect from the winter semester 2023/24.
