Context: Global Compact for Migration

- The United Nations adopted the **Global Compact for Safe, Orderly and Regular Migration** (GCM) in 2018.
- The Compact is the **first international framework** on migration from which targets and measures are to be implemented by the international community at national, regional and global level.

Context: Sustainable Development Goals (SDGs)

- The United Nations' **2030 Agenda** describes migration as a phenomenon that affects all countries of the world as countries of origin, transit countries and host countries.
- International cooperation is essential for **safe, orderly and regular migration** that promotes development and guarantees the human rights of migrants and refugees.
- **10.7** facilitate orderly, safe, and responsible migration and mobility of people, including through implementation of planned and well-managed migration policies

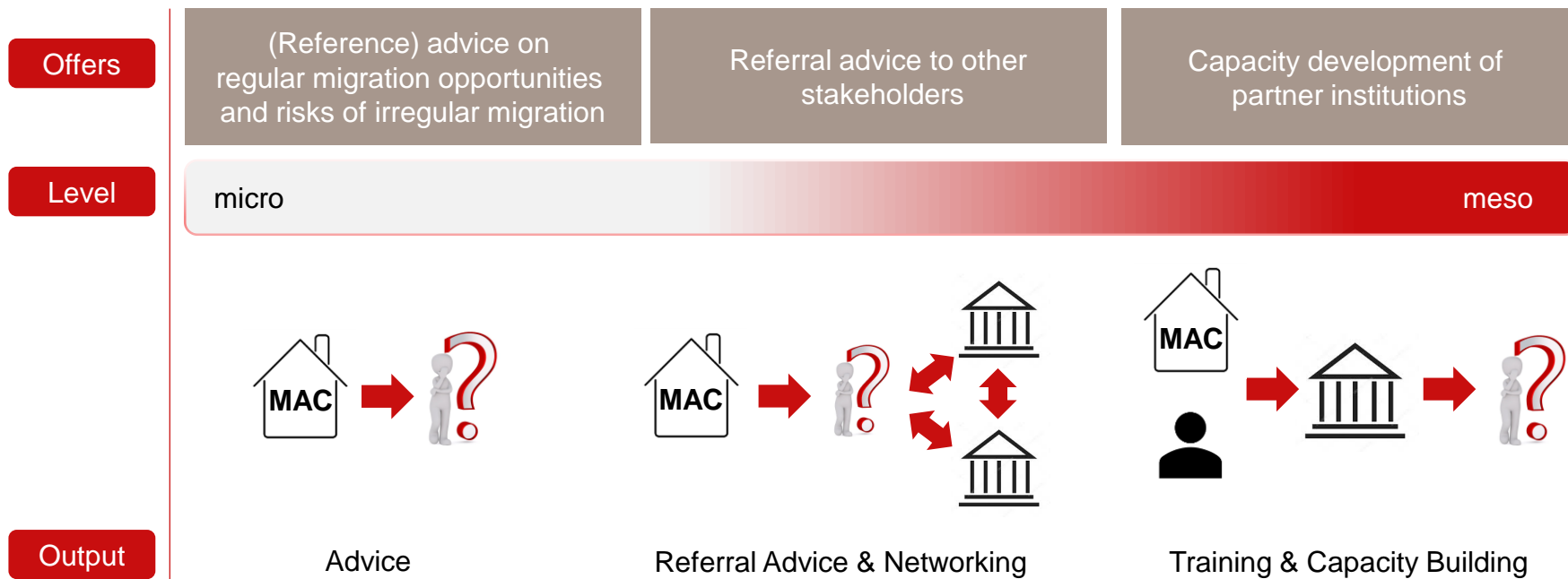
