#### **Context: Global Compact for Migration**

- The United Nations adopted the **Global Compact for** Safe, Orderly and Regular Migration (GCM) in 2018.
- The Compact is the **first international framework** on migration from which targets and measures are to be implemented by the international community at national, regional and global level.



#### **Context: Sustainable Development Goals (SDGs)**

- The United Nations' **2030 Agenda** describes migration as a phenomenon that affects all countries of the world as countries of origin, transit countries and host countries.
- International cooperation is essential for safe, orderly and regular migration that promotes development and guarantees the human rights of migrants and refugees.




